The Third European Conference on Fetal Alcohol Spectrum Disorders



The Third European Conference on Fetal Alcohol Spectrum Disorders was held from 20 to 22 October 2014 in Rome. The main conference was attended by about 190 professionals and parents from 23 countries around the world. The conference was held in the centrally located Casa dell'Aviatore, the air force officers club.



Overview of the conference program

The main conference consisted of an intensive program of 2 1/2 days, featuring key researchers from abroad as well as presenting the latest research from European groups. Speakers included Ken Warren, Christina Chambers, Phil May, Ed Riley, Peter Hammond, Claire Coles, Magnus Landgren, Joanne Rovet, Osman Ipsiroglu, and so many more, covering the whole range from prevention to diagnosis and care. A Monday afternoon session highlighted the use of video for FASD education and awareness, presenting three film projects. Highly esteemed talks were given by Samantha Marchant, a birthmother, and by Michaela Thomas, an adult with FASD. The closing session on Wednesday morning dealt with ethical issues related to aspects of diagnosis and children's rights. Margaret Murray closed with a talk on how we can work together to address FASD in Europe and North America.
