7th European Conference on FASD 2024 Madrid (Spain), 2024, September 22+23-25

The European FASD Alliance (www.eufasd.org) and VisualTEAF (https://visualteaf.com) organized the Seventh European Conference on FASD (https://eufasd2024.com) – Fetal Alcohol Spectrum Disorders: clinical and biochemical diagnosis, screening and follow-up, which took place in Madrid, September 22 to 25, 2024.

The main goal of this conference was to bring together European researchers, clinicians, public health workers, FAS-related NGOs and parents in order to share latest knowledge and promote collaborations.

Our objective was to open your minds to new ideas about FASD, related to diagnosis, prevalence, biomarkers, interventions, quality of life, etc., and also to open a window to scientific research and public opinion. This meeting in Madrid was the next step to a multifactorial point of view of FASD, including also parents of children with biological, foster or adoptive families.

In the confusion of non-scientific opinions about alcohol consumption during pregnancy, with many deleterious economic interests, our message was still **no evidence of harm does not mean evidence of no harm**. In short, no level of alcohol consumption during pregnancy can be considered safe.

Conference brief report of EUFASD 7

The Conference developed at the Ministry of Health, Madrid, and included 2 main parallel meetings:

- 1. Patient and Carer's Day on Sunday, 22 September, at Caixa Forum Center, leaded by VisualTEAF, Spain
- 2. Clinical Workshop on FASD, at the same Ministry of Health, leaded by Miguel del Campo, from UCLA, USA

Finally, the EUFASD General Assembly was postponed.
